Dear Superintendent Dobbins and Limestone School Board Members,

I recently was made aware that it was decided not to continue supporting the work of Eastern Aroostook Adult and Community Education for the residents of Limestone. While I am sure you did not make this decision lightly, I wanted to provide you with more information on how adult education serves the residents of Limestone and why your support is critical to our work. Please consider the following:

How has Eastern Aroostook Adult and Community Education served and benefited the residents of Limestone in 2021?

In the two semesters of 2021, Eastern Aroostook Adult and Community Education had 48 Limestone resident registrations in programming that included basic literacy development, high school completion with diploma or HiSet, college transitions, and workforce training.

Certified teachers provide a total of 5,435 hours of direct instruction for these Limestone residents.

These residents ranged in age from 17-52, and 29 of those residents received some form of public assistance.

How the proposed MOU would help Eastern Aroostook Adult and Community Education continue this important work for the residents of Limestone.

The State of Maine Department of Education provides a subsidy to school units based on the students between the ages of 17 and 20, served through adult education programs. This subsidy is at the same per pupil rate as the grade 9-12 students within the district. In the time frame for which the subsidy was calculated, Eastern Aroostook Adult and Community Education had 25 student registrations from this age group with a total of 93 courses. In the 2023 ED279, Limestone Public School was credited with 9.3 FTEs for the adult education course that were delivered to Limestone high school aged children that year resulting in a subsidy of \$71,749.50.

While the ages of the students served were 17-52, the MOU only requests financial support through the ED279 subsidy that was generated through our work with the 17-20 year old students. The thought behind this arrangement is that Limestone can support the advancement of all of its adult population and the workforce while not having to commit any local tax dollars. In fact, while Eastern Aroostook Adult and Community Education provided all of the resources needed to deliver the 5435 hours of instruction, Limestone Public Schools would receive a net revenue of \$28,699.80 to offset the local tax burden.

Thoughts to leave you with.

Eastern Aroostook Adult and Community Education works primarily with the most vulnerable and disadvantaged population in the communities we serve. Our goal is to assist adults who strive to improve their personal and financial well-being through education and training. In addition to the dedication and professionalism of our staff, we require financial support to make this work happen. The structure of the MOU not only supports the development of the human capital within the Limestone community, it also provides a financial windfall for the Limestone Public Schools. I hope you will

reconsider your decision to discontinue your support of this important work and continue to partner with us in our efforts to help improve the self-sufficiency of individuals, strengthen families, and improve the workforce within the Limestone community one person at a time.
